

## RESOLUTION

R 143-07/08

**WHEREAS** the City of Selma invited and accepted bids during the period of November 27, 2007 through December 11, 2007 on a bid proposal on Baseball Equipment (RD2008-A). Further detailed specifications were given in the BID (RD-2008-A); and

**WHEREAS** the City Clerk has complied with Sections 41-16-50 through 41-16-63 of the Code of Alabama, 1975, and has given notice thereof by advertising the bid in City Hall and further by notice to selective vendors; and

**WHEREAS** the City Clerk opened the sealed bids on December 11, 2007 and Olympia Sporting Goods was the lowest responsible bidder for Item #s 4, 6, 7 and 24, McClendon Athletic Center was the lowest responsible bidder for Item #s 2, 3, 5, 15, 18, 19, and 20, Taylor Sports was the lowest responsible bidder for Item #s 1, 8, and 17, and Riddell was the lowest possible bidder for Item #s 9, 10, 11, 12, 13, 14, and 16.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SELMA AS FOLLOWS:**

That the City Clerk is hereby ordered to forward a signed copy of said resolution to Olympia Sporting Goods, McClendon Athletic Center, Taylor Sports, and Riddell notifying the same of the City of Selma's acceptance and approval of the bid and is hereby awarded the contract of the Baseball Equipment in the amount of Three Thousand Five Hundred Sixty Seven and No/ Dollars (\$3,567.00) for Olympia Sporting Goods, in the amount of Fifteen Thousand Two Hundred Seventy Nine Dollars and Seventy Cents (\$15,279.70) for McClendon Athletic Center, in the amount of Five Thousand Three Hundred Four and No/Dollars (\$5,304.00) for Taylor Sports, in the amount of Four Thousand Five Hundred Eighty Three Dollars and Sixty Five Cents (\$4,583.65) for Riddell, for a grand total bid amount of Twenty Eight Thousand Seven Hundred Thirty Four Dollars and Thirty Five Cents (\$28,734.35).


**BE IT FURTHER RESOLVED** that the following "Miscellaneous Equipment and Repairs" (1.6600.156-0) line item be used to purchase Baseball Equipment and that the budgeted amount is Fifty Four Thousand and No/ Dollars (\$54,000.00).

That the Mayor, James Perkins, Jr., in his official capacity as Mayor, is hereby directed to proceed with the execution of the contract awarded to Olympia Sporting Goods, McClendon

Athletic Center, Taylor Sports, and Riddell.

The City Council further authorizes the payment of the amount to be paid from the Recreation Miscellaneous Equipment and Repairs Account (1.6600.156-0), allocated in the approved FY 2007-2008 budget.


